Cancer's impact is staggering and changes the course of thousands of lives every year. The mission of the KLL Scholarship Foundation is to provide financial assistance to eligible candidates, enabling them to pursue their dreams through a college education.

The KLL Scholarship opportunity is a \$1,000 gift, renewable for up to a total of four years (\$4,000 total maximum). Scholarships are awarded annually based on the following criteria:

- The loss of a parent (biological or non) to cancer before the age of 22.
- A US citizen.
- Attend a 2- or 4-year (minimum) higher education establishment.
- Have an interest in education, arts, math, science or the environment.
- Show service involvement in the community, church, school, or other non-curricular activity.
- Indicate financial need.
- Submit a completed application, including personal essay and reference.
